Wife: "Wake up! You'll catch a cold while you're taking a nap here...Hey...So...The

sleeping face is usually lovable, but that of my husband is never lovable. This loose face is Buddha, a huge statue of Buddha....The thought of dedicating my lifetime to him makes me sick. Alas...he is mumbling something with a sour face...What's up?... Oh, he is



smiling now...Alas, he has a nightmare, wearing a sullen look. What kind of Dream are you dreaming? Wait! Where are you rolling over?"

Hachi: "Ah...Ah-a, Ah....Ah-, I was sleeping."

Wife: "Only sleeping? Hey, what kind of dream were you dreaming?"

Hachi: "well."

Wife: "What kind of dream were you dreaming?....I'm now asking you what kind of dream you were dreaming."

Hachi: "I was not dreaming."

Wife: "You were dreaming. You were frowning, smiling, mumbling. You must be dreaming a funny dream. What kind of dream were you dreaming?"

Hachi: "I was not dreaming."

Wife: "You're a liar. You were dreaming."

Hachi: "I'm sure I wasn't dreaming."

Wife: "Well, Did you see the dream you couldn't tell me about?"

Hachi: "It's ridiculous. If I did, I'd tell you. I wasn't dreaming. So I'm saying I wasn't dreaming."

Wife: "Liar...You were dreaming. Whatever dream you were dreaming, it's a mere story of dream, isn't it? Why are you making a poor excuse for it? You say, 'I had a trashy dream.' and laugh wildly. That's the end. But you're so secretive."

Hachi: "Secretive...? I'm really not dreaming."

Wife: "Aha, I see. You had a worthless dream, so you can't tell anybody about it, I think. Maybe it must be a dream of having an affair with a woman."

Hachi: "No kidding. Why must I have such a dream? I wasn't dreaming, so I'm saying I wasn't dreaming."

Wife: "Weren't you dreaming? How obstinate you are! I see, you must have a dream about which you can't say to anybody. What on earth did you do? How much did you spend in Gion(downtown in Kyoto)?"

Hachi: "I wasn't doing anything."

Wife: "You, a goat!"

Hachi: "A goat! I didn't go to Gion nor anywhere. I was taking a nap."

Wife: "You're a goat, so you had a dream about which you couldn't tell anybody."

Hachi: "A goat, a goat. Shut up!"

Wife: "A goat is a goat."

(They go on quarreling.)

Neighbor: "Stop, stop, stoooop! What a noisy couple you are! It may be your hobby or entertainment, but think of your neighbors. I know, 'One should not interfere in lover's quarrels.' Though, you're crying, 'Goat! Goat!' I can hear you...Lady, why are you crying? What's up?"

Wife: "Well, my neighbor. Listen to me! Today, at last...."

Neighbor: "What happened today?"

Wife: "He was taking a nap here. I thought he might catch a cold, so I tried to wake him up. I thought he had a nightmare with a sour face. But suddenly he grinned and talked in his funny dream. So I woke him up and asked what kind of dream he had. But he said he was not dreaming how many times I asked. He can tell me about it. If he had talked about the dream, I'd laugh at him. That's the end. But he says he was not dreaming." (She cries)

Neighbor: "That's why you were quarreling...You'll live a long life....I see. Madam, my wife was making Manjus(a bun with a bean-jam filling). Why not come to my house and eat Manjus, relaxing your time with my wife. Go, go. You are really troublesome."

Hachi: "Thank you so much anytime."

Neighbor: "You're welcome. Well, I don't know what kind of dream you were having, but your wife was bitterly crying, saying you didn't tell her about your dream. By the way, what kind of dream did you have?"

Hachi: "I was really not dreaming."

Neighbor: "Well, well. Sometimes you have a dream you don't want to talk to your wife about. ...Hey, why not tell me a little...? I'll never talk to anyone. A little to me, ...a little...."

Hachi: "You, if I had a dream, I'd first talk to my wife. I was never dreaming."

Neighbor: "I'll never speak to anyone. If I'm told never to speak to anyone, I'll speak to nobody, whatever may happen to me."

Hachi: "If I had dreamed, I'd have talked to you. Really I didn't have a dream." (They are quarreling.)

Landlord: "Stop, stop!...How noisy my apartments are! I never patrol here without seeing any troubles. You are good friends, aren't you?"

Neighbor: "Mr. Landlord, listen to me! I'm so ashamed of being a good friend with this guy for a long time. In short, this guy was quarreling with his wife here. So I tried to reconcile the quarrel. It is said, 'A peace-maker is the angel of the hour.' I'm a peace-maker. I asked them why you were making a quarrel. According to his wife, 'He was taking a nap here. When she was trying to wake him up so that he

wouldn't catch a cold, he began to cry or smile. Maybe he was dreaming an interesting dream. So she woke him up and asked him what kind of dream he was dreaming. He told her he had never been dreaming. So she was quarreling with him. That's why I became a peace-maker and stopped their quarrel...And my wife is making Manjus, so I advised his wife to go and eat them and I told him, 'Why not talk to me about your dream? I keep a secret. If I am told never to talk to anyone, I'll never talk to anyone what may happen.' But this guy told me he had never dreamed. What an obstinate man he is!"

Landlord: "What are you saying? You, idiot! If you have a time to inquire into others' dream, you must work earnestly. You haven't paid the rent for three months."

Neighbor: "This is different from that...."

Landlord: "What an ass! Come home! Get away!...How troublesome you are!"

Hachi: "Mr. Landlord. I always appreciate your kindness. Now I found he was an obstinate person.

Landlord: "Both of you...are a person of leisure...Well the story of your dream, it seems to be a very interesting one."

Hachi: "It's nonsense..."

Hachi: "Cool down!"

Judge: "I'll unfasten your rope until you decide to tell me about the dream."

(The judge entered the house. It became darker and darker. He couldn't move. He wanted to pee. He was hungry. He felt lonely. Then a gale of wind lifted him up into the sky.)

Hachi: "Lucky, the rope was unfastened. Where on earth am I? Ah, are you Tengu(a long-nosed goblin)?"

HAchi: "What happened to...?"

Tengu: "You say again such a thing."

(Long nails dug into his body.)

Hachi: "Oh, no. Help me....!"

Wife: "Wake up...My darling. You're suffering from a nightmare. What kind of dream did you have?" (2019/12/31)
